## RESULTS

The OneFamily 2018 AGM was attended by 130 members.

The Board answered questions on dividend payments; the appointment of and ongoing assessment of KPMG as auditor to the Society; Board diversity; the gender pay gap and equal pay; Board remuneration; OneFamily's ethical fund; cyber security; and profit levels.
