The objective of the OneFamily Global Select 100% Shares fund is to achieve medium to long-term growth by investing in higher risk investments. To achieve its objective the fund invests in one or more collective investment schemes, prioritising investments with ethical / sustainable selection criteria where possible.

The fund will aim to invest up to 100% indirectly in riskier assets like global equities.

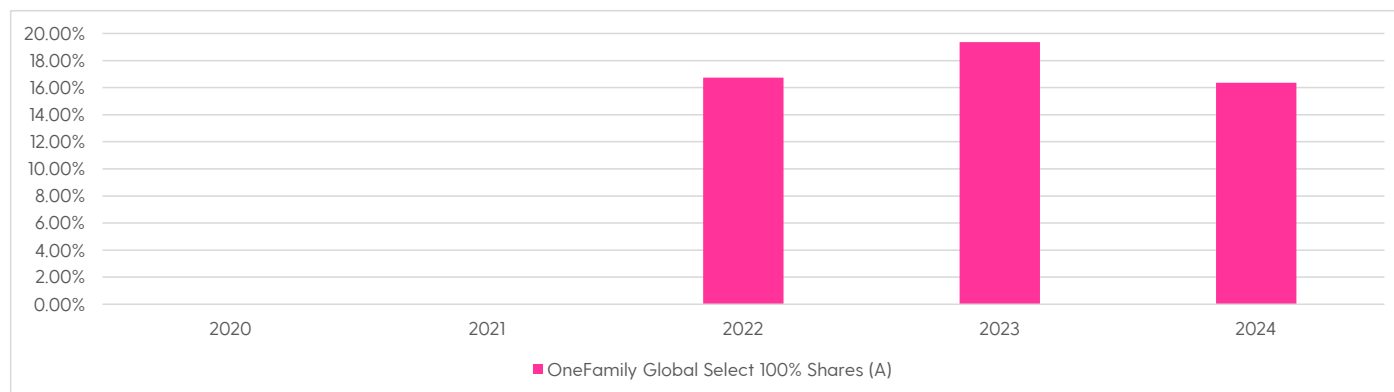

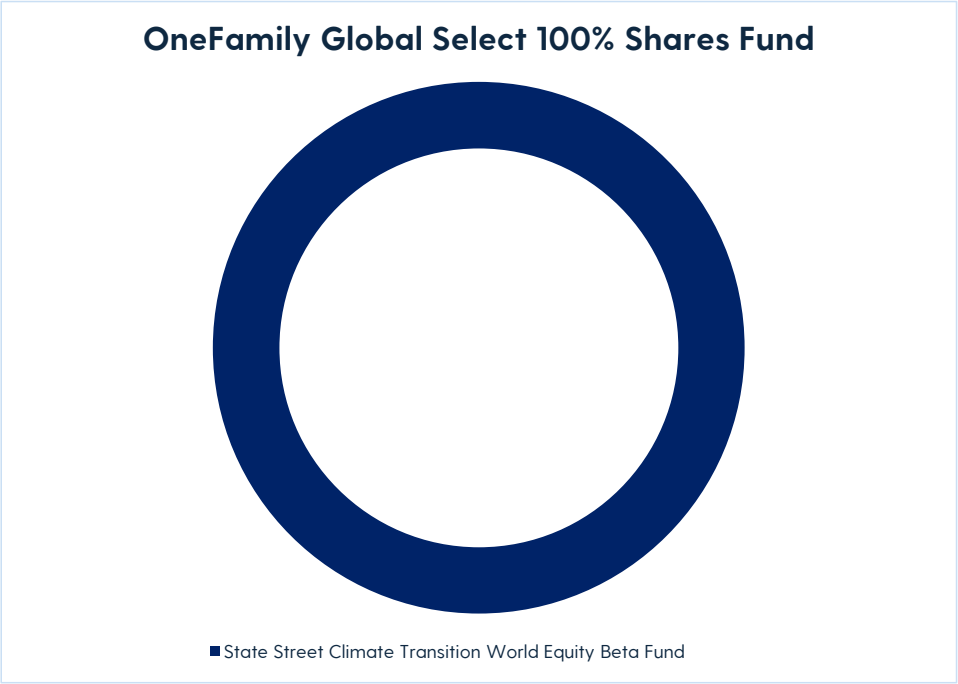
